## **Membership Eligibility**

Joining the 'Planet Asia' panel (Asia Monitor's panel) is free and is open to individuals only (not corporations or other business companies) that are at least thirteen (13) years of age.

If you are below than eighteen (18) years of age and win any prize or receive any cash reward through Planet Asia Points or other Planet Asia's incentive program, then such award will be made to your legal guardian. Only one account is permitted in the panel.

## **Registration and Passwords**

To register, you must provide all the details in the online registration form. You must provide Asia Monitor with complete and valid contact information, your full legal name, home address, valid email address, and all other requested information. The account that you created must have a unique and valid email address and upon submission of form, we will provide you a password.

Once completed, this will allow you to create an account in your name and any points you earned via participating in the survey will be properly credited to your account.
